

NALEO Educational Fund will implement a community-based engagement and mobilization campaign, to ensure the Latino population is accurately counted in the 2020 Census.



- Submit comments to the Census Bureau opposing the addition of the citizenship question. The Bureau is requesting the comments as part of the administrative process it must conduct to move forward with various Census 2020 preparations. The comments are due by March 15, and you can submit them to 2020\_Census\_Comments@omb.eop.gov your comments should indicate they are in reference to Docket number OMB-2018-0004.
- Amplifying your opposition to the addition of the citizenship question to your constituency and stakeholders.
